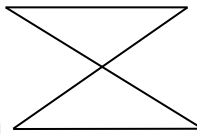

- 「Isuzu Business Department No.1」 and 「Isuzu Business Department No.2」 will be reorganized into 「Isuzu & Mobility Business Department」

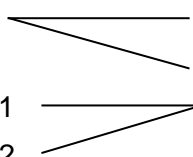

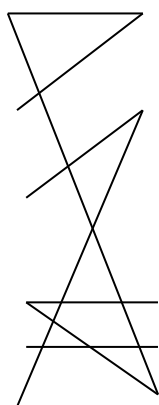

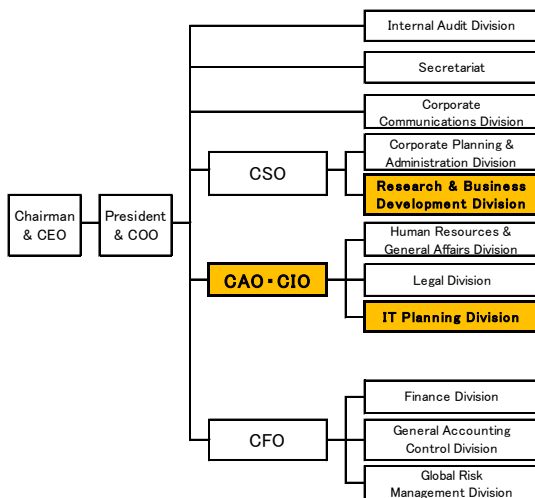


III. Administrative Organizations

CDO・CIO

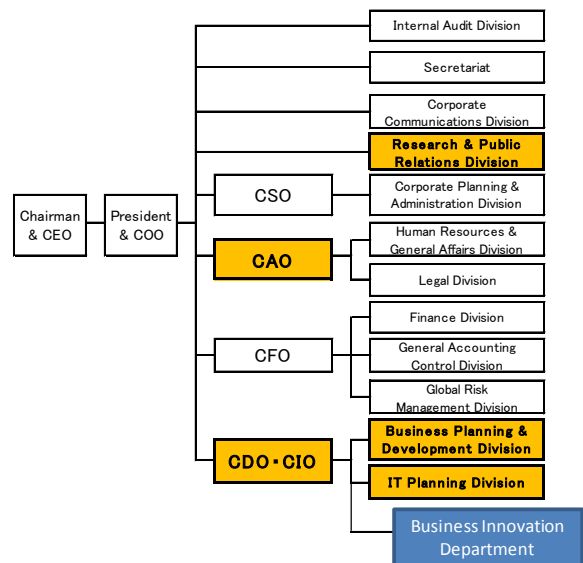
