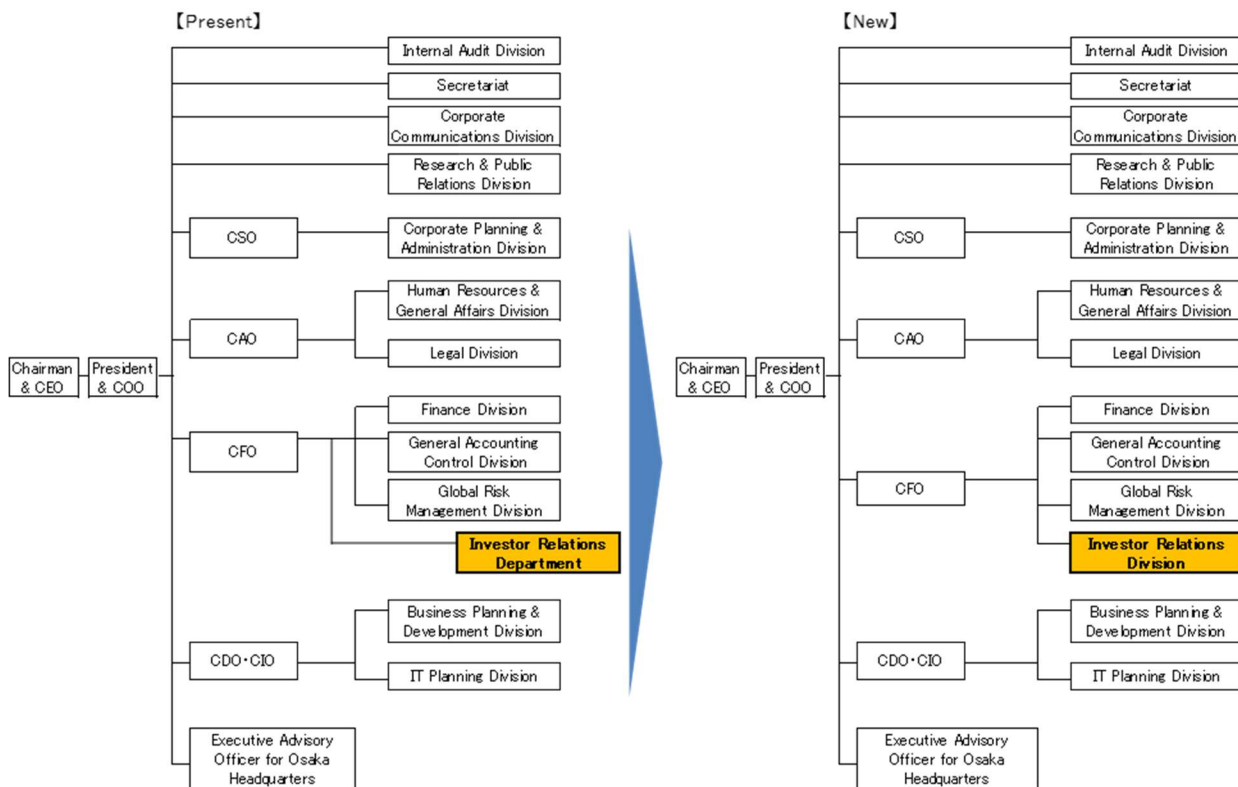
ITOCHU Corporation has announced an organizational change taking effect as of January 1st, 2021.
