3. Creation of Senior Operating Officer

We create a new post called Senior Operating Officer.

Tenure of Executive Officers (except for Executive Officers with managing titles and Executive Officers of important posts including Presidents of Division Companies and Officers responsible for overseeing each administrative functions) will be limited to 2 years, and upon the end of the tenure, all of them will leave the office. Among above leaving Executive Officers, those who will continue to owe the same task or be transferred to the other internal positions will be appointed as Senior Operating Officers.

Executive Officers with managing titles and Executive Officers of important posts including Presidents of Division Companies and Officers responsible for overseeing each administrative functions will be in principle appointed from Senior Operating Officers or those who had been Executive Officers and moved out to group companies.

Senior Operating Officers are senior to Executive Officers (except for Executive Officers with managing titles and Executive Officers of important posts including Presidents of Division Companies and Officers responsible for overseeing each administrative functions).

4. Appointment of Women to Executive Officer Positions

We establish a special measure applicable only to women to be appointed as Executive Officers.

We will give them special occasions to have an experience about headquarters management as executives and foster their further growth.

Based on this special measure, as of April 1st ,2024, we will appoint additional 5 female Executive Officers, and as a result, the number of female Executive Officers will be 6 and occupy 16% of all Executives Officers and 21% of all Officers (Directors, Audit & Supervisory Board Members and Executive Officers).
