**Announcement Regarding the Status of Repurchase of Own Shares**

(Repurchase of the Company's shares in accordance with the Articles of Incorporation under  
Article 165, paragraph 2 of the Companies Act of Japan)

ITOCHU Corporation ("ITOCHU") decided at the meeting of the Board of Directors held on August 5, 2024 to repurchase own shares in accordance with Article 156 of the Companies Act of Japan, as applied pursuant to Paragraph 3, Article 165 of the Companies Act of Japan. ITOCHU hereby announces the status of the repurchase as follows.

1. Progress of the repurchase until November 30, 2024
  - (1) Type of shares repurchased: Common stock of ITOCHU
  - (2) Total number of shares repurchased: 4,726,800 shares
  - (3) Total amount: 36,332,329,300 yen
  - (4) Period: From November 1, 2024 to November 30, 2024
2. Accumulated total of the repurchase until November 30, 2024 pursuant to the above resolution
  - (1) Total number of shares repurchased: 14,363,200 shares
  - (2) Total amount of shares repurchased: 107,795,210,000 yen
