ITOCHU Announces Establishment of ITOCHU Health Charter Aimed at Enhancing

Corporate Value by Promoting Employee Health

ITOCHU Corporation (headquartered in Minato-ku, Tokyo; Masahiro Okafuji, President & CEO; hereinafter "ITOCHU") announced today that it has established the ITOCHU Health Charter in order to help enable employees, our greatest management resource, to carry out the infinite missions required of them and thereby enhance corporate value for many years to come.

ITOCHU has been a pioneer in reducing excessively long working hours and encouraging efficient workstyles through reforms such as the "morning-focused work system," and company management believes that supporting the good health of its employees is one of the most important aspects of reforming workstyles. ITOCHU also believes that good health is essential not only for achieving physical and spiritual fulfillment but is also the driving force that enables people to proactively pursue their mission. Promoting the good health of employees also strengthens the company's human resources and is therefore fundamental to ITOCHU's management strategy.

It is good health that enables each member of ITOCHU's diverse workforce to achieve their potential and that, in turn, helps ITOCHU to retain its position as a top-level *sogo shosha*.
